[REDACTED] Jefferson City, Mo., [REDACTED], telephonically contacted the investigating Agent and advised as follows:

On July 23, 1993, she was working at her regular place of employment, [REDACTED] Jefferson City, Mo., telephone number (314) [REDACTED]. She had previous been a witness to the shooting of WILLIAM DALE JONES in May, 1993. While at work on July 23, 1993, she had been telephonically contacted by an individual who identified herself as [REDACTED], the mother of JONES.

[REDACTED] had previously telephonically contacted CASE at work on July 21, 1993, and [REDACTED] ended up hanging the phone up on [REDACTED], because of the types of questions [REDACTED] was asking of CASE. During the conversation on July 23, [REDACTED] kept trying to change and twist [REDACTED] description of what she saw when JONES was shot. [REDACTED] again ended the telephone conversation by telling [REDACTED] she didn't want to talk to her about it, and hanging up.

[REDACTED] advised she did not want to talk to [REDACTED] anymore, and wished that she would leave her alone. [REDACTED] advised she was not asking the FBI to do anything re the above, but she wanted to make the FBI aware what [REDACTED] was doing.
