THE COURT: Please be seated, ladies and gentlemen. 6 7 You realize you're still under oath, Mr. Alwan? THE WITNESS: Yes, sir. 8 THE COURT: Okay. You may proceed, Mr. Gillogly. 9 10 MR. GILLOGLY: Thank you, your Honor. SHARIF A. ALWAN, DEFENDANT HEREIN, PREVIOUSLY SWORN, 11 12 CROSS EXAMINATION (RESUMED) BY MR. GILLOGLY: 13 14 Mr. Alwan, when we broke for lunch, I was asking you some questions about things that you told the grand jury and some 15 16 things that you never told the grand jury, and I want to 17 continue asking you some questions along that vein. Yesterday you testified about the treatment, you 18 described the treatment that you say the Shimbet people did to And I think you said something to the effect that you 20 21 felt like you were hanging or you were hung between life and 22 death, something to that effect. Did I hear you correctly? ∥Ą. Yes. 23

All right. Now, sir, when you went before the grand jury

in July of 1998, you never told them that you had hung between

MR. HILL: I can't put Ms. Jarad on to explain that or myself, and these arguments were directed as to the civil contempt. There were no issues regarding criminal contempt at this point. We were making arguments for why he should be released. And it puts us in a position, it leaves the impression, I think where he's going is why didn't you bring that up in the civil contempt proceedings.

THE COURT: Okay.

MR. HILL: And there may well have been reasons that it wasn't brought up that we're precluded from going into at this point.

THE COURT: I have previously excluded any references to the civil contempt. I'm going to continue to hold that to that ruling.

So I think it's my suggestion, Mr. Gillogly, that where you're headed seems to me to be somewhere that might violate that ruling.

MR. GILLOGLY: Judge, here's the problem. Mr. Hill and Ms. Jarad have chosen a legal strategy which puts in issue what this man said or didn't say along the way, this whole process along the way, and they're painting this, or attempted to paint this picture of unfairness and this guy was disregarded and ignored.

This jury ought to know what he really said and what he really didn't say if he said it in counsel's presence. You

know, I'm sorry, that's the defense they chose to raise. 1 2 THE COURT: You're just talking about his statements. MR. GILLOGLY: And statements of counsel when he was 3 4 present. That's where you lose me. Statements of 5 THE COURT: counsel, while we're still dealing with the civil contempt, 6 those are out of bounds. 7 8 MR. GILLOGLY: But he adopts them, Judge. example, one clear example -- I'm sorry. I didn't mean to 9 10 interrupt the Court. 11 THE COURT: Go ahead. 12 MR. HILL: Can you keep it down, Judge? MR. GILLOGLY: One clear example, and I think it was 13 14 Ms. Jarad, "This man fears he's going to be prosecuted." A 15 page or two later, Mr. Alwan says, "I say what my lawyer just 16 Judge, it's as clear as you can say, "I adopt what she 17 said." Now, it's unfair to us, Judge, that, you know, they've chosen this defense tactic, we didn't. We objected, but here 18 19 we are. 20 MR. HILL: How do I put on what Ms. Jarad was doing? 21 I mean, I think, without calling her? I mean, you're getting 22

I mean, I think, without calling her? I mean, you're getting into counsel's strategy, you're getting into the arguments that were made on behalf of his continued detention and civil contempt.

- 12 Q. On July 11th of this year, when you appeared before Judge
- 13 Kocoras with Ms. Jarad for the second immunity order, and when
- 14 | there was a discussion about whether or not you would testify
- 15 and whether it was even worthwhile for you to go back to the
- 16 grand jury, nobody told Judge Kocoras that you had a fear or
- 17 | concern about an immediate threat to your family.
- 18 A. I think, your Honor, for explanation just, when I express
- 19 | my feelings in front of Judge Kocoras that I will be assaulted
- 20 | when I go back to visit my family, that was the fear in my
- 21 | feelings that immediately when I enter the borders, that I will
- 22 | be arrested once again. That's what I meant about it.
- 23 But I did not mention anything in specific words to
- 24 ||express that it was immediate threat, that's correct.
- 25 Q. In your three grand jury appearances and in your three

- 1 |appearances before two judges of this court, not once did
- 2 anyone say anything to the court or to the grand jury that you
- 3 | had a concern about an immediate threat to your family.
- 4 A. Yes.
- 5 Q. In fact, sir, the only time that you expressed any concern
- 6 was a concern about you personally.
- 7 A. I believe I did mention my kids and my family and my wife
- 8 and my parents when I go and visit them there.
- 9 Q. You mentioned your wife and your children, Mr. Alwan --
- 10 A. Yes.
- 11 |Q. -- in the context of explaining to the grand jury why you
- 12 | would be going back to your homeland. That's true, isn't it?
- 13 A. That's true.
- 14 Q. Not that they were in any kind of immediate danger, isn't
- 15 | that true?
- 16 A. At that time, yes.

- Now, on June 7th, you said that -- you appeared before
- 21 Judge Aspen again in this building.
- 22 A. Yes.
- 23 Q. And Mr. Jarad and -- Ms. Jarad, excuse me, and Mr. Hill
- 24 were with you at that time.
- 25 A. Yes.

- 1 MR. GILLOGLY: May I approach, your Honor?
- 2 THE COURT: Yes.
- 3 BY MR. GILLOGLY:
- 4 Q. Mr. Alwan, I'm going to give you what's marked as
- 5 Government Exhibit 8. Would you take a look at that, sir.
- 6 MR. GILLOGLY: Judge, this one's not in the binder
- 7 either.
- 8 | THE COURT: Okay.
- 9 BY MR. GILLOGLY:
- 10 $\|Q$. And I'd like to direct your attention, Mr. Alwan, if it
- 11 helps you, to page 3.

And his concern or 9 10 fear, genuinely based, based on the political 11 situation, even currently ongoing, he has a genuine concern and fear that he would be prosecuted once he 12 travels out there, and he will need to travel out 13 14 there." 15 Did I read that correctly, sir?

- 5 Q. Would you take a look at Government Exhibit 3A for a
- 6 moment, Mr. Alwan.
- 7 (Counsel conferring.)

- 9 Q. All right. Mr. Alwan, have you had a chance to look at
- 10 Government Exhibit 3A -- which is in evidence, your Honor --

- Now, you testified yesterday, Mr. Hill asked you some questions about why you wouldn't testify three months ago and why you're willing to testify today.
- Do you remember Mr. Hill asked you those questions?
- 12 A. Yes.

- Q. Okay. And would you tell us, please, again why it is that you don't have a fear now, but you did three months ago?
- A. I do still have the fear, and three months ago, the stand
 was different. And today the consequences I might face after
 not testify will be harder to me.
- It is like I will be able -- I won't be able to get my
 citizenship as citizen of this country. I might lose my green
 card. I'm subject to deportation.
- Q. You understand, Mr. Alwan, that as a citizen of this
 country, you have an obligation to obey the lawful court orders
 that are entered?
- 24 A. Yes, I do.
- 25 Q. And you did not do that, did you, Mr. Alwan?

- 1 A. I did not obey that, that's correct.
- 2 Q. And you knew that you were required to obey the order of
- 3 the court to testify.
- 4 A. Yes.
- 5 Q. Today, you've decided that you are going to testify --
- 6 | yesterday and today, you've decided that you're going to
- 7 testify.
- 8 A. I am in defendant stand to defend myself, and I believe I
- 9 have the right to defend myself.
- 10 Q. Mr. Alwan, my question to you is three months ago, you
- 11 | weren't willing to testify. Today and yesterday, you are
- 12 | willing to testify, is that correct?
- 13 A. I did not understand the question. Where is --
- 14 Q. I'll be happy to repeat it, sir.
- 15 A. Thank you.
- 16 Q. In July -- on July 11th, 2000, you, sir, decided that you
- 17 | were not going to obey Judge Kocoras's order to you, didn't
- 18 | you?
- 19 A. Yes.
- 20 Q. Today, sir, you have decided that you are going to

- 5 court order or not obey a court order.
- 6 A. If it was something about me -- would you repeat the
- 7 | question, please.
- 8 Q. Sure.
- 9 Today, you have it in your mind that you want
- 10 something for yourself. You don't want to go back to your
- 11 | homeland apparently. Do I understand you correctly?
- 12 A. That's correct.
- 13 Q. And so because you don't want to go back to your homeland,
- 14 | you are willing to get on this witness stand and to testify.
- 15 A. That's right.
- 16 |Q. But you weren't willing to do that back in July of this
- 17 | year, three months ago.
- 18 A. That's correct.
- 19 Q. And you weren't willing to do that back in July of 1999.
- 20 A. That's correct.
- 21 Q. But today, you are.
- 22 A. Yes.
- 23 Q. So in short, Mr. Alwan, your decision not to testify in
- 24 July of this year, three months ago, had absolutely nothing to
- 25 do with any threat to your family.

- 1 A. I disagree.
- 2 Q. Now, Mr. Alwan, is it your testimony that it's now safe
- 3 | for you to testify?
- 4 A. I believe with that big publicity, that will make it
- 5 | little safer, but it is a hard stand as I believe.
- 6 Q. Mr. Alwan, you think the publicity is going to protect
- 7 you, is that your testimony, sir? Do I understand you
- 8 |correctly?
- 9 A. No, sir, but that might at least give a picture that if
- 10 something happens to my family or to me, who's behind that.
- 11 |Q. Now, explain to the jury, please, why it is that your
- 12 | testimony before a grand jury would have subjected you or made
- 13 you vulnerable to some kind of arrest or torture or abuse at
- 14 the hands of the Israelis?
- 15 A. I did not understand the question. Would you repeat it
- 16 ||slowly, please?
- 17 Q. Did you testify yesterday that you refused to testify in
- 18 the grand jury because you feared that if you did testify
- 19 | before the grand jury, the Shimbet or the Israelis then would
- 20 | harm you, torture you?
- 21 A. That's correct.
- 22 Q. Can you tell the jury, please, how it was -- what's the
- 23 ||connection then between you testifying in a grand jury in
- 24 Chicago and then being set upon by Shimbet sometime in the
- 25 future, maybe, back in the West Bank?

- A. I believe that the questions I was asked in front of the grand jury, which is coming from the heart of the Shimbet, and I have given no assurance that any answers that I give that will go back to the Shimbet themselves, that will put me in danger, in immediate danger.
- And those questions, I did not understand them, and they are not the matter of the question today.
- Q. Well, Mr. Alwan, what is it about the questions that were to be put to you that would anger the Shimbet such that they would retaliate against you if they ever caught you back in your homeland?
- 12 A. I will keep the answer to myself at this moment.
- 13 Q. I'm sorry, sir? I didn't hear you.
- 14 A. Well, after the torturing period of my days, there was
 15 nobody ever questioned me why you stand the torture, why there
 16 is no more statement.
- I was in torture to be used at the hand of the

 Israelis in the United States which I refuse to do under fear,

 threat, trying to buy me at the same time, and I did explain

 that --.
- 21 |Q. All right --
- 22 A. -- to my attorneys.
- Q. I'm sorry. I'm not going to ask you about any discussions
 you had with your attorneys, Mr. Alwan. That's a privileged
- 25 communication that you have.

- My question to you, sir, and I do not understand your
 answer. What is it about the questions that were put to you in
 the grand jury would cause the Shimbet people to arrest you and
 torture you if they caught you back in your homeland after
 this?
 - A. Because simply this testimony will -- that declare the lies they made against me and somebody else in the United States, and that declare their status and their threat to me that these documents will be turned to the United States if you don't cooperate with us, which is a hard stand I took it since those years and I suffer hard consequences because of that.
- 12 Q. I'm sorry, who suffered what?
- 13 A. I suffer hard consequences because of that, the threat of the Israelis, and something else.
- 15 Q. All right. Let me see if I understand this, Mr. Alwan.

In August of 1995, you wrote that Arabic statement that you talked about this morning. You were also interviewed by Israeli authorities. Certain information was written down.

It's your testimony that that information was forced out of you and, and, it's false. Do I understand that correctly?

- Q. Are you testifying that you believe that the questions put to you in the grand jury had come from or originated with the
- 25 Shimbet?

- 1 A. Of course.
- 2 Q. All right. So if you're asked questions in the grand jury
- about things that were already known to Shimbet, how is it,
- 4 Mr. Alwan, that when if you returned to your country and if the
- 5 Shimbet were ever to know that you testified about such things
- 6 in the grand jury you would be retaliated against?
- 7 A. Before I came to the United States, I have a meeting with
- 8 the Shimbet. They did threat me, direct threat that anything
- 9 that goes wrong that you will be in danger and it will cost you
- 10 your life.
- 11 Q. Is it your testimony today that before you came to the
- 12 United States, the Shimbet found you and told you -- told you
- 13 | what?
- 14 A. They did not find me.
- 15 $\|Q$. All right.
- 16 A. They refused to give me my right to come back to the
- 17 United States. They refused me to make me use the airport to
- 18 come back. They deny that. And during a meeting with the
- 19 Shimbet, they did with threat directly to me.
- 20 Q. When was this meeting? I'm sorry. I didn't mean to cut
- 21 you off.
- 22 A. I came here June 1999, I believe it was around June 22 or
- 23 21, 1999, which is -- that carries the date of that roundtrip
- 24 | ticket I took.
- 25 Q. And it is your testimony that right before you came back

- 1 in June of 1999, people from Shimbet talked to you.
- 2 A. Yes.
- 3 Q. And they told you what, sir?
- 4 A. They told you -- they told me exactly that you'll find
- 5 yourself, we're scared of you and if you do anything wrong, we
- 6 are scared of this trip, you will be like, some specific names
- 7 they mentioned that like Abdullah and his brother, which were
- 8 they were two people they were killed, and nobody knows who
- 9 killed them at that time.
- 10 Q. Did I understand you to say that these people that you
- 11 thought were from Shimbet told you that they, meaning Shimbet,
- was afraid of you? Did I hear you correctly?
- 13 A. Yes.
- 14 Q. And that if you said anything about Shimbet, something bad
- 15 would happen to you?
- 16 A. Yes. They did make some cross-examinations, too.
- 17 Q. Now, Mr. Alwan, you never told that to the grand jury, did
- 18 you?
- 19 A. Never.
- 20 Q. You did not tell it to Judge Aspen.
- 21 A. Never.
- 22 Q. You did not tell it to Judge Kocoras.
- 23 A. Never.
- 24 Q. In fact, sir, you didn't even say it yesterday, did you?
- 25 A. I was hoping these things will be over and before I have

- 1 to say it.
- 2 Q. Now, Mr. Alwan -- so if I -- is it your testimony that you
- 3 were afraid that if you went public, made a statement to
- 4 somebody that the Shimbet had committed these acts of torture
- 5 against you, then something bad would happen to you?
- 6 A. I don't know what's going to happen, but --
- 7 Q. But they made some sort of ominous threat, you said. Did
- 8 I understand correctly?
- 9 A. Will you explain what's "ominous."
- 10 Q. I'm sorry. They made some kind of threat to you that
- 11 | frightened you.
- 12 A. The testimony, you mean?
- 13 Q. Let me withdraw the question.
- 14 A. Go ahead, please.
- 15 $\|Q$. When you met -- you described in this meeting you met the
- 16 | Shimbet.
- 17 A. That's right.
- 18 $\|Q$. And they told you they were afraid of you.
- 19 | A. Yes.
- 20 Q. And they told you, in so many words, that if you said
- 21 anything about their torture of you that something bad would
- 22 happen to you, is that the gist of it?
- 23 A. Not just the torture.
- 24 Q. I'm sorry?
- 25 A. I did have threat from them.

- 1 Q. What threat did they make to you?
- 2 A. They told me anything that goes wrong, it will cost you
- 3 your life.
- 4 Q. Could cost you your life. If you were to say something
- 5 about Shimbet, then they would kill you?
- 6 A. I believe they are capable to do that.
- 7 Q. That's -- my question to you, sir, is that what those
- 8 people told you --
- 9 A. Yes.
- 10 0. -- in June of 1999?
- 11 A. Yes.
- 12 Q. Now, Mr. Alwan, in fact, sir, you have made a number of
- 13 statements at various times alleging these acts of torture,
- 14 | haven't you?
- 15 A. Yes.
- 16 Q. You told the Red Cross.
- 17 A. Yes.
- 18 Q. You told the Israeli Ministry of Justice.
- 19 A. Yes.
- 20 Q. They were going to do an investigation. Is that your
- 21 | testimony this morning?
- 22 A. Yes.
- 23 Q. All right. You told your lawyer.
- 24 A. Yes.
- 25 Q. You told your father.

- 1 A. I didn't told my father. You mean about the torturing?
- 2 Q. The torture, yes.
- 3 A. Yes.
- 4 Q. You told your brother Yasser.
- 5 A. Yes.
- 6 Q. You told your brother Ramadan.
- 7 A. Yes.
- 8 Q. All right. None of those people has been arrested?
- 9 A. None of them.
- 10 Q. Tortured?
- 11 A. No.
- 12 Q. Put a hood over their head?
- 13 A. No.
- 14 |Q. Shaken?
- 15 A. Nobody.
- 16 Q. Tied to a chair?
- 17 A. No.
- 18 Q. Beaten?
- 19 A. Nobody.
- 20 Q. Where is your father living?
- 21 A. He lives in the West Bank, Einybrod, Ramallah.
- 22 Q. I'm sorry?
- 23 A. He lives in the West Bank, Einybrod, Ramallah, which is
- 24 | the village.
- 25 Q. Now, sir, in August of this year, after you were charged

- 1 with the offense that you are now on trial for, you, acting
- 2 through your lawyer, made a public accusation against Shimbet,
- 3 |didn't you?
- 4 A. I have the right to defend myself.
- 5 Q. Nobody's questioning that right, sir.
- 6 My question to you was on August 1st of this year,
- 7 | just a little over two months ago, two-and-a-half months ago,
- 8 || your lawyer made a public charge against Shimbet that they had
- 9 | tortured you.
- 10 A. Yes.
- 11 |Q. All right. Now, after that, sir, you had your father sign
- 12 | a statement which said that you had accused Israeli
- 13 | authorities, Shimbet in particular, with torturing you while
- 14 | they were holding you in 1995, isn't that true?
- 15 |A. Will you repeat the question, please?
- 16 Q. Sure. After your lawyer made a public charge that you
- 17 were the victim of torture by Shimbet, you asked your father to
- 18 ||sign a statement that was filed in a public pleading in this
- 19 | courthouse, and in your father's statement, he says that you,
- 20 | the son, Sharif, made accusations of torture by Shimbet. Isn't
- 21 | that true?
- 22 ||A. Except with some correction. I'm familiar with that
- 23 | statement, and I read it, but I haven't asked my father to do
- 24 | it. He did it. Thank you.
- 25 Q. Your father signed that statement, didn't he?

- 1 A. Yes.
- 2 Q. And in it, he says that you, his son Sharif, made a
- 3 public -- or made an accusation of torture against Shimbet,
- 4 |correct?
- 5 A. I make an accusation?
- 6 MR. GILLOGLY: May I approach, your Honor?
- 7 THE COURT: Yes.
- 8 BY MR. GILLOGLY:
- 9 Q. I'm going to show you what's been marked as Government
- 10 Exhibit 10, Mr. Alwan. Take a look at that.
- 11 That's your father's statement?
- 12 MR. HILL: May we have it?
- 13 BY THE WITNESS:
- 14 | A. Yes.
- 15 BY MR. GILLOGLY:
- 16 |Q. And that statement, sir, was filed in the public record,
- 17 ||if you will, filed publicly in this courthouse.
- 18 A. Yes.
- 19 Q. Your father is living in the West Bank.
- 20 A. Yes.
- 21 Q. In the very same area where Shimbet operates, correct?
- 22 A. Yes.
- 23 Q. Has your father been arrested?
- 24 A. My father is an American citizen.
- 25 Q. Has your father been arrested?

- 1 | A. No, sir.
- 2 |Q. Has he been tortured?
- 3 | A. No, sir.
- 4 Q. Has he been hooded?
- 5 A. No, sir.
- 6 Q. Put in that chair.
- 7 | A. No, sir.
- 8 |Q. Your wife. Has she been arrested?
- 9 A. No.
- 10 Q. Nobody put a hood over her head.
- 11 A. No.
- 12 Q. Nobody put her in a chair.
- 13 A. No.
- 14 $\|Q$. Your two daughters, have they been arrested?
- 15 A. No, sir.
- 16 Q. They're safe and sound, aren't they, Mr. Alwan?
- 17 A. I hope they are.
- 18 Q. Now, Mr. Alwan, do you have a binder up there, sir, that
- 19 ||black binder?
- 20 A. Yes, I do.
- 21 |Q. Would you please open it to the grand jury testimony of
- 22 |July 11th of this year.
- Now, before I go into that, I want to ask you this:
- 24 | Is it your testimony, sir, that you were willing to obey the
- 25 Court's order and to testify before the grand jury except for

- 1 this fear that you've described the last couple of days?
 - A. Repeat the question, please.
- 3 Q. I'll be happy to.

- Is it your testimony -- withdrawn.
- Sir, in July of this year in the grand jury, would you
- 6 have testified if you didn't have these fears that you've
- 7 described to the jury?
- 8 A. If I don't have these fears?
- 9 Q. If you did not have those fears, would you have testified?
- 10 A. I believe if somebody gave me some assurance, some certain
- 11 points, that I might took different stand.
- 12 Q. We'll look at that, we'll look at that.
- I understood your testimony from just a little while
- 14 ago to say that you were threatened that if you were to expose
- 15 the torture of you by Shimbet, that they would kill you?
- 16 A. Not the torture, no.
- 17 Q. I'm sorry? I cannot hear you.
- 18 A. The statement's not right.
- 19 Q. Okay. Correct it for me, would you?
- 20 A. It's not talking about the torturing, but it is something
- 21 beyond that.
- 22 |Q. Did you just tell this jury that you met with some Shimbet
- 23 people who threatened you and told you not to tell anybody what
- 24 they had done to you?
- 25 A. Not I told them that, no.

- 1 Q. Mr. Alwan, if you could keep your voice up.
- 2 A. No, sir.
- 3 Q. What did they tell you?
- 4 A. What did they tell me?
- 5 \mathbb{Q} . Yes, what did those -- the people you thought were from
- 6 Shimbet --
- 7 A. Yes.
- 8 Q. -- in June of 1999, what did they tell you?
- 9 A. They told me that we are afraid of this trip that you're
- 10 going to make, and anything that goes wrong, you're going to
- 11 suffer the consequences, which is they mean by definitely --
- 12 they mean by it about the arrest that was arrested before
- 13 because they did ask specifically about some United States
- 14 | residents who live in the United States, where do they live,
- 15 before they made this threat to me.
- And I was wondering why they made it, and I was told
- 17 | them that -- that why should you do that to me? Why should you
- 18 | threat me? Meanwhile this thing is over. I have done my time.
- 19 I served my time, whether I was guilty or not. I've served my
- 20 time and I get out, and they have nothing to do with you.
- 21 They did -- they did not allow me to use the airport.
- 22 | They did try to entrap me at that Allenberg Bridge at the last
- 23 | moment before I leave. There was somebody who was serve jail
- 24 at the day time that was served that was trying to give me
- 25 3,000 dinar to carry that out of the check point before I stamp

- 1 my passport. And at that moment, I refuse, of course, to take
- 2 | it. After that, I was taken to that Shimbet office again --
- 3 Q. Mr. Alwan, let me go back to the question I asked you.
- 4 A. Go ahead.
- 5 Q. Did these people that you believed were Shimbet tell you
- 6 | why they were afraid of the trip you were going to make to the
- 7 United States?
- 8 A. They never made that.
- 9 Q. I'm sorry?
- 10 A. They never made that clearly to me.
- 11 Q. All right. Well, did you understand these people to be
- 12 saying to you, Sharif Alwan, don't you dare talk about the way
- 13 we, Shimbet, treated you while you were in custody, or else we
- 14 | will kill you?
- 15 A. It wasn't that statement like the way that we torture you
- 16 or the way that goes in there.
- I believe they have some other concern, concerns if I
- 18 made any testimony against them.
- 19 Q. What is it, Mr. Alwan, that you understood these people
- 20 wanted you to keep your mouth shut about?
- 21 A. I believe that the information that came through the
- 22 | Shimbet has misled the justice system and the FBIs through the
- 23 country against some innocent people; that their names, they
- 24 were mentioned in the torturing situation, they drove me in to
- 25 work against those people. They have nothing to do with HAMAS

- 1 organization or anything else. That's why.
- 2 Q. All right, I'm sorry. Are you telling the jury that these
- 3 | fellows did not want you to repeat the statements that they had
- 4 | written down and said you had said?
- 5 A. No, that's not the statements.
- 6 Q. Did they threaten you about some other people?
- 7 A. It is I assume that -- they know that there is an ongoing
- 8 investigation in the United States, and it's clearly they are
- 9 part of it.
- 10 Q. Now, Mr. Alwan --
- 11 A. They don't want any finger to be point at them.
- 12 Q. Have you finished your answer?
- 13 A. Thank you.
- 14 Q. No, have you finished?
- 15 A. Yes.
- 16 Q. Now, I don't suppose you have the names of these people
- 17 ||who talked to you in June of 1999?
- 18 A. I just remember one of them.
- 19 Q. And what is this person's name?
- 20 A. I'm sorry, I can't mention no names.
- 21 Q. I'm sorry?
- 22 A. I can't mention no names publicly.
- 23 Q. So you won't answer the question.
- 24 A. I said I cannot mention any names publicly.
- 25 Q. Mr. Alwan, we'll come back to that.

- 1 Mr. Alwan, do you have the book in front of you?
- 2 A. Yes, I do.
- 3 Q. When you went into the grand jury, Mr. Alwan, and I want
- 4 to turn your attention to Exhibit Number 4, which was the July
- 5 Grand Jury. I'll start your attention on page 6.
- 6 A. I'm sorry, would you repeat the exhibit?
- 7 Q. It's behind tab number 4, and beginning on page 6, okay?
- 8 A. Go ahead.
- 9 Q. Now, you testified earlier, sir, that you believed that
- 10 | the questions that were being put to you in the grand jury had
- 11 | originated with the Israelis.
- 12 A. Yes.
- 13 Q. And you told this jury this morning that the information
- 14 | that was written down in the reports was false.
- 15 A. Yes.
- 16 |Q. Untrue.
- 17 | A. Yes.
- 18 Q. All right. Mr. Alwan, direct your attention to page 6,
- 19 the very -- the second question on that page.
- 20 | "Mr. Chanenson asked you: Mr. Alwan, is it true that
- 21 you were recruited into the HAMAS organization in
- 22 approximately 1990?"
- 23 Do you see that question?
- 24 | A. Yes.
- 25 Q. All right. And you said:

- "Sir, I am refusing to answer any questions to this
 grand jury. Is that clear?"
- 3 A. That's clear.
- 4 Q. All right. Now, Mr. Alwan, nobody asked you any questions
- 5 | in that grand jury about the way you were treated by Shimbet,
- 6 did they?
- 7 A. No, they did not.
- 8 Q. And you're telling this jury today that you were not
- 9 | recruited into HAMAS organization in 1990. Is that true?
- 10 A. That's true.
- 11 Q. I mean is that your testimony?
- 12 A. Yes.
- 13 Q. All you had to tell the grand jury was, "No, sir, that's
- 14 | not true."
- 15 A. My testimony is I'm not a HAMAS member, and I've been
- 16 | alleged to say that.
- 17 Q. And all you had to say to Mr. Chanenson was, "No, sir, I
- 18 am not a member of HAMAS, isn't that true?
- 19 A. That's true.
- 20 Q. Next question, they asked you if Muhammad Salah was one of
- 21 the individuals who was responsible for your military training
- 22 | in the HAMAS organization.
- 23 Do you see that question?
- 24 A. Yes.
- 25 Q. All right. And you're telling this jury that Muhammad

- 1 Salah was not responsible for your military training in HAMAS
- 2 | because you were not a member of HAMAS, correct?
- 3 A. Repeat the question, please.
- 4 | 0. Sure.
- 5 You're telling us today that you are not a member of
- 6 HAMAS, and this Salah fellow was not anybody who was
- 7 | supervising you in HAMAS.
- 8 A. That's correct.
- 9 Q. So all you had to do was tell Mr. Chanenson, "No, sir,
- 10 | that's not true."
- 11 A. At that time.
- 12 Q. You didn't have to mention word one about Shimbet in
- 13 | answering that question, did you, Mr. Alwan?
- 14 A. No, I did not.
- 15 Q. All you had to say was, "No, sir, that's false." Isn't
- 16 | that correct?
- 17 A. My stand was different at that time.
- 18 $\|Q$. Going down the page, Mr. Alwan. Mr. Chanenson asked you:
- 19 ("Mr. Alwan, is it true, is it true that at some point at
- 20 Muhammad Salah and Mousa Abu Marzook's direction you attended
- 21 ||military training for HAMAS in the United States?"
- Now, you're telling us today that this is not a true
- 23 statement. Do I understand you correctly?
- 24 A. Yes.
- 25 Q. And so all you had to say to Mr. Chanenson's question is,

- 1 "Sir, no, it is not true."
- 2 A. At that time, the answer should be yes or no.
- 3 Q. Sir, all you had to say to Mr. Chanenson's question is
- 4 "No, sir, that's not true."
- 5 A. What was if I say it was true. There is two possibilities
- 6 for answering that question. How could you assume that answer
- 7 | is no or yes?
- 8 Q. Mr. Alwan, didn't you just tell this jury that you are not
- 9 a member of HAMAS?
- 10 A. Yes, I did.
- 11 Q. All right. So the answer to this question then for
- 12 Mr. Chanenson is "No, Mr. Chanenson, that is not true."
- 13 A. That's true.
- 14 |Q. All right. But you didn't say that to Mr. Chanenson.
- 15 A. No, I didn't.
- 16 Q. And Mr. Chanenson didn't ask you word one about Shimbet,
- 17 did he?
- 18 A. No, he did not.
- 19 Q. Or how you were treated when you were arrested, did he?
- 20 A. No, he did not.
- 21 Q. Next page, Mr. Alwan.
- 22 Mr. Chanenson said to you: "Mr. Alwan, is it true
- 23 that you traveled overseas to Syria and to Lebanon to
- 24 partake in military training on behalf of the HAMAS
- 25 organization?"

- You tell this jury today that you never did any of those things.
- 3 A. That's true.
- 4 Q. So all you had to say to Mr. Chanenson's question on page
- 5 7 there is "No, sir, that is not true."
- 6 A. Not at that point.
- 7 Q. Nobody asked you anything about Shimbet.
- 8 A. Nobody asked me about Shimbet.
- 9 Q. Next question:
- "Mr. Alwan, for your trip to Syria to attend the training camp, did Muhammad Salah provide you with
- the airplane tickets for that trip?"
- 13 Are you telling this jury that Muhammad Salah did not
- 14 provide you with any airplane tickets for a trip to Syria?
- 15 A. I have no connection with HAMAS organization.
- 16 Q. So when Mr. Chanenson asked you that question, the answer
- 17 to his question would be "No, sir. Mr. Salah did not provide
- 18 me with the airplane tickets for any trip anywhere."
- 19 A. That's correct.
- 20 Q. You didn't have to say word one about Shimbet.
- 21 A. That's correct.
- 22 |Q. All right. Now, bottom of the page.
- Oh, then you say to Mr. Chanenson:
- "I did make my stand clear in front of the judge that
- I'm coming to this room and I'm not going to testify.

- 1 | Is that clear, please?"
- 2 Did you say that there on page 7?
- 3 A. Yes.
- 4 Q. All right. Then Mr. Chanenson asked you:
- 5 On your trip for training in Lebanon, you spent
- 6 approximately two months at a Hezbollah military
- 7 camp, is that right, sir?"
- Now, today, Mr. Alwan, you're telling this jury that
- 9 you didn't spend any time at any Hezbollah camp or any military
- 10 training in Lebanon.
- 11 A. That's correct.
- 12 Q. Do I understand you correctly?
- 13 A. Yes.
- 14 Q. So the answer to Mr. Chanenson's question is "No, sir,
- 15 | that is not right."
- 16 A. That's right.
- 17 Q. Nobody asked you anything about Shimbet.
- 18 A. Nobody asked me at that time.
- 19 Q. Nobody asked you how you were treated during your
- 20 | captivity in 1995 and '96.
- 21 A. Nobody.
- 22 |Q. Then you left the room, Mr. Alwan.
- 23 A. Yes.
- 24 Q. And you met with Ms. Jarad.
- 25 A. Yes.

- 1 |Q. And then you came back to the grand jury.
- 2 A. Yes.
- 3 Q. And when you came back to the grand jury, Mr. Chanenson
- 4 asked you some more questions.
- 5 "Now, sir, I asked you if during your time in the
- 6 Hezbollah military camp in Lebanon, you spent
- 7 approximately two months training there, is that
- 8 correct?"
- 9 Your answer to that question, Mr. Alwan, is what?
- 10 || A. Is no.
- 11 Q. "No, I didn't, Mr. Chanenson," but you didn't say that,
- 12 |did you?
- 13 A. No, I didn't.
- 14 Q. You didn't -- nobody asked you about Shimbet.
- 15 A. Nobody.
- 16 Q. Nobody asked you about your time in captivity, did they?
- 17 A. No, they didn't.
- 18 Q. Page 8 and 9, two more questions:
- 19 Mr. Alwan, at some point near the end of your
- 20 | training, you were told that you would be involved in
- 21 HAMAS activities in Jordan, but that you would return
- 22 to the United States first, is that correct?"
- 23 You're telling us today, Mr. Alwan, that that is not
- 24 ||correct.
- 25 A. That's not correct.

- 1 |Q. But you didn't say that --
- 2 |A. I'm sorry, the statement is not correct.
- 3 ||Q. That's right. The statement is not correct.
- 4 A. The answer is yes.
- 5 Q. But you didn't say to Mr. Chanenson, "No, sir, that is not
- 6 |correct. That was not your response in the grand jury, was
- 7 ||it?
- 8 A. I did not respond, that's correct.
- 9 Q. Nobody asked you about Shimbet.
- 10 A. Nobody did.
- 11 Q. Nobody asked you about your time in captivity.
- 12 A. Nobody did.
- 13 Q. Now, yesterday, Mr. Alwan --
- Judge, I don't know what your plan is, but --
- 15 | THE COURT: Do you want to break at this point?
- MR. GILLOGLY: Yeah, my throat's hurting, Judge, but
- 17 | I'm getting there.
- 18 | THE COURT: Okay. We'll take a ten-minute recess.
- 19 (Recess from 3:02 to 3:19 p.m.)
- 20 THE COURT: Please be seated, ladies and gentlemen.
- 21 Mr. Alwan, you can retake the stand.
- 22 You can proceed, Mr. Gillogly.
- MR. GILLOGLY: Thank you.
- 24 BY MR. GILLOGLY:
- 25 Q. Mr. Alwan, yesterday your lawyer, Mr. Hill, was asking you

- some questions about why you did what you did or why you refused to testify in the grand jury.
- Do you remember that whole series of questions from your lawyer yesterday afternoon?
- 5 A. Yes.

from that.

- Q. And among the questions he asked you, Mr. Alwan, is he asked you about whether or not you would have been willing to testify before the grand jury if someone had offered you some protection for yourself from any consequences that might come
- Do you remember that series of questions on that score from Mr. Hill?
- 13 A. Yes, he did ask that. Yes, he did ask that, I think.
- 14 Q. Again, I know it's getting late. Would you like some 15 water or something, Mr. Alwan?
- 16 A. No, I'm fine. Thank you.
- 17 Q. If you can keep your voice up so we can all hear you.
- 18 A. Go ahead.
- 19 Q. Now, you told the jury yesterday in response to Mr. Hill's
- 20 questions that if somebody had offered you protection, that you
- 21 | would have testified. Is that your testimony?
- 22 A. I can't recall what -- I can't recall what I said
 23 yesterday.
- 24 Q. You can't recall what you said yesterday?
- 25 All right. Well, let me ask you this: If someone had

- 1 offered you protection, would you have testified in a grand
- 2 ||jury?
- 3 A. Yes.
- 4 Q. Yes?
- 5 A. If somebody would offer me assurance, you said.
- 6 Q. Protection for yourself.
- 7 A. Yes.
- 8 Q. You would have testified.
- 9 A. Yes.
- 10 Q. Now, Mr. Alwan, you never asked for protection, did you?
- 11 A. No.
- 12 Q. You never asked Judge Kocoras?
- 13 A. No.
- 14 Q. You never asked Judge Aspen.
- 15 A. No.
- 16 Q. You never asked the grand jurors.
- 17 A. No.
- 18 Q. And you never asked the government.
- 19 A. I never ask nobody. That's the answer for the whole
- 20 | questions.
- 21 |Q. Now, Mr. Hill also asked you some questions yesterday
- 22 |about the secrecy of the grand jury. Do you remember that?
- 23 A. Yes.
- 24 |Q. And Mr. Hill asked you, Mr. Alwan, that if someone had
- 25 told you that the proceedings, your testimony in front of the

- 1 grand jury, was secret, you would have testified.
- 2 A. Yes. I believe yes.
- 3 Q. That was your testimony to the ladies and gentlemen of the
- 4 | jury yesterday.
- 5 A. Uh-huh.
- 6 Q. That if someone would have told you that the proceedings
- 7 before the grand jury were secret, you would have testified.
- 8 A. Yes.
- 9 Q. And you told the jury yesterday that nobody told you that
- 10 the proceedings before the grand jury were secret.
- Do you remember testifying to that in front of the
- 12 jury yesterday?
- 13 | A. Yes.
- 14 Q. You told them that no prosecutor told you that the
- 15 proceedings before the grand jury were secret.
- 16 A. Yes.
- 17 Q. And you told the ladies and gentlemen of the jury that no
- 18 judge told you that the proceedings before the grand jury were
- 19 ||secret.
- 20 MR. HILL: Your Honor, may I have a side bar, please?
- 21 | THE COURT: I don't think we need one on this one,
- 22 Mr. Hill.
- 23 You can answer it.
- 24 BY MR. GILLOGLY:
- 25 Q. Do you remember the question, sir?

- 1 A. Yes, I believe I said -- yes, I believe I said yes.
- 2 Q. That no judge told you that the proceedings before the
- 3 grand jury were secret. That was your testimony yesterday.
- 4 A. I don't recall the exact answer. I'm sorry about that.
- 5 Q. Did you tell the ladies and gentlemen of the jury
- 6 | yesterday that no judge told you that your testimony before the
- 7 || grand jury was secret? No judge ever told you that.
- 8 A. That's what I understand. If it's secret, to me, it means
- 9 to stay in the border of the court, and it wouldn't be -- fly
- 10 to another country or --
- 11 |Q. Mr. Alwan, I'm sorry. You've got to keep your voice up so
- 12 | we can all hear you.
- 13 A. Yes. If you mean about -- when I answered that, when I
- 14 | testified that, that I believe nobody assure me that this is a
- 15 secret meeting or a secret jury, and nobody gave me assurance
- 16 | that any information will never flee back to the Shimbet or
- 17 ||somewhere else.
- 18 Q. All right. And you said that no grand juror ever assured
- 19 you that your testimony would be secret.
- 20 A. Yes.
- 21 |Q. Now, Mr. Alwan, did you mean what you said yesterday when
- 22 you told the ladies and gentlemen of the jury that if someone
- 23 | had told you that the grand jury proceedings were secret, you
- 24 | would have testified before the grand jury?
- Did you mean it when you said it to the ladies and

- 1 gentlemen of the jury yesterday?
- 2 A. Yes, I do mean it.
- 3 Q. Were you telling them the truth yesterday?
- 4 A. Sure, I was telling them the truth because I told them
- 5 | that --
- 6 0. So the truth, Mr. Alwan --
- 7 | A. Let me --
- 8 Q. I'm sorry. So the truth, Mr. Alwan, is that if someone
- 9 had told you the proceedings before the grand jury were secret,
- 10 then you, sir, Sharif Alwan, would have testified in the grand
- 11 || jury.
- 12 A. I would have took different stand, yes.
- 13 Q. The truth, Mr. Alwan, is that you were told that the
- 14 proceedings before the grand jury were secret.
- 15 A. Not I recall.
- 16 Q. Do you recall, Mr. Alwan, asked you a number of questions
- 17 | about the various proceedings that you've had in this case,
- 18 | where you've gone before judges with your lawyers to talk about
- 19 whether or not you're going to testify, okay?
- 20 Do you remember on June 7th of this year, you,
- 21 Ms. Jarad and Mr. Hill went before Judge Aspen. Do you
- 22 | remember that?
- 23 |A. Yes.
- 24 |Q. And one of the issues that was before the judge that day
- 25 was your concern about having to testify.

- 1 A. Yes.
- 2 Q. And you wanted to be basically excused from having to
- 3 | testify, is that a fair statement?
- 4 | A. Yes.
- 5 Q. You were trying to get Judge Aspen not to order you to
- 6 | testify. Do you remember that?
- 7 A. That's not what my interest was at that time.
- 8 Q. No, my question, sir, is that proceeding on June 7th
- 9 | before Judge Aspen where you, Mr. Hill, Ms. Jarad and the
- 10 ||prosecutors were there, was about whether or not you were going
- 11 | to have to testify, correct?
- 12 A. Was about what kind of -- we were seeking for some kind of
- 13 decision from the court in the status that I have.
- 14 Q. All right. Now, in that proceeding on June 7th,
- 15 Mr. Alwan, your lawyer told Judge Aspen, and we've read this
- 16 | before, that you feared prosecution back home, in your
- 17 | homeland, do you remember that?
- 18 A. Yes.
- 19 $\|Q$. All right. And you recall just a little while later
- 20 Mr. Chanenson said something to the judge.
- 21 Do you remember Mr. Chanenson, the Assistant U.S.
- 22 Attorney, the prosecutor?
- 23 A. Yeah.
- MR. GILLOGLY: All right. May I approach, your Honor?
- 25 THE COURT: Yes.

- 1 MR. GILLOGLY: Government Exhibit 8, counsel.
- 2 BY MR. GILLOGLY:
- 3 Q. I'm going to show you Government Exhibit 8, Mr. Alwan --
- 4 | let me take the rest of these back here.
- 5 And you've given some testimony about Government
- 6 Exhibit 8 already, and I'd like to turn your attention to page
- 7 6, Mr. Alwan. Do you have it there, sir?
- 8 A. Yes.
- 9 Q. Page 6? And if you would, sir, would you turn your
- 10 | attention to starting about line 16 on that page.
- 11 A. Yes.
- 12 Q. Now, you recall that your counsel had told Judge Aspen
- 13 that you were afraid of prosecution back in your homeland. And
- 14 | then the prosecutor had a chance to respond, and you were
- 15 present, Mr. Alwan, were you not?
- 16 A. Sure, I was.
- 17 \mathbb{Q} . And so you heard Mr. Chanenson say the following things to
- 18 ||Judge Aspen:
- 19 | "And at this point, Mr. Alwan's fear, I would submit
- 20 to your Honor, is premature and not necessarily
- 21 objectively reasonable. These grand jury proceedings
- 22 are secret, and the possibility of eventual
- 23 disclosure is speculative at this time."
- 24 And so, Mr. Alwan, you were told by a prosecutor in
- 25 front of a judge with both of your lawyers present that the

- 1 proceedings before the grand jury was secret.
- 2 A. Your Honor --
- 3 | 0. Is that true?
- 4 A. -- my understanding at that time, that this secrecy is not
- 5 ||what I mean about it --
- 6 THE COURT: You need to direct your answer to
- 7 Mr. Gillogly's question.
- 8 THE WITNESS: I'm sorry.
- 9 BY MR. GILLOGLY:
- 10 Q. Sir, you were present when the prosecutor told the judge
- 11 | in front of you and your lawyers that the proceedings before
- 12 the grand jury were secret.
- 13 A. I was there, yes.
- 14 | Q. And, yet, Mr. Alwan, when you went into the grand jury
- 15 | four weeks later on July 13th, you refused to obey Judge
- 16 Kocoras's order directing you to testify.
- 17 A. Yes.
- 18 Q. You made that decision not to testify.
- 19 A. Yes.
- 20 Q. You knew you were obliged to testify, correct?
- 21 A. Yes.
- 22 Q. You knew, there was no uncertainty in your mind, you knew
- 23 | what that order required you to do.
- 24 ∥A. Yes.
- 25 Q. And you, sir, decided not to obey Judge Kocoras's order of

- 1 ||July 13th, 2000.
- 2 A. Yes, but not --
- 3 Q. Mr. Alwan, the reason you did not testify before the grand
- 4 | jury on July 13th or any -- either of the other two grand
- 5 | juries, in July of '98 and July of 99, is because, sir, you did
- 6 | not want to talk about people in the HAMAS organization.
- 7 A. That's not correct.
 - MR. GILLOGLY: Nothing further, your Honor.
- 9 THE COURT: Redirect examination.
- 10 REDIRECT EXAMINATION
- 11 BY MR. HILL:

- 12 Q. That last document that counsel asked you about, do you
- 13 remember you did appear before Judge Aspen with Ms. Jarad,
- 14 ||didn't you?
- 15 A. Yes, I did.
- 16 Q. And you appeared before Judge Aspen with Ms. Jarad as well
- 17 |as myself, isn't that correct?
- 18 A. That's correct.
- 19 Q. And the Assistant United States Attorney, as counsel said,
- 20 | did say these grand jury proceedings are secret, correct?
- 21 A. Correct.
- 22 Q. But he went on to say something else, too. There was an
- 23 | "and" after that, isn't that correct?
- 24 Do you have it there, sir?
- 25 MR. HILL: May I approach, Judge?

- 1 THE COURT: Yes.
- 2 BY MR. HILL:
- 3 Q. He's given you a copy of what was said by the Assistant
- 4 United States Attorney, hasn't he? He gave you a copy of it,
- 5 ||right?
- 6 A. Correct.
- 7 Q. And what Mr. Chanelson said was, "The grand jury
- 8 proceedings are secret, and the possibility of eventual
- 9 disclosure is speculative at this time."
- 10 Is that what Mr. Chanelson said?
- 11 | A. Yes.
- 12 Q. He specified that there was a possibility that this
- 13 | information could be disclosed, did he not?
- 14 MR. GILLOGLY: Objection, your Honor. Could we have
- 15 Mr. Alwan testify, and not Mr. Hill?
- 16 THE COURT: The objection is sustained. Rephrase the
- 17 question.
- 18 BY MR. HILL:
- 19 |Q. What did the prosecutor say? You read his words right
- 20 here.
- 21 |A. "These grand jury procedures" --
- 22 |Q. Slowly and loudly and as clearly as you can.
- 23 |A. "These grand jury procedures are secret, and possibility
- 24 | that eventual disclosure is spec -- is speculative and --
- 25 Q. It says "at."

- 1 A. "At this time." I'm sorry.
- 2 |Q. What did you understand Mr. Chanenson saying possible
- 3 disclosure of this grand jury material -- let me ask you this:
- 4 Did you understand that to mean that this
- 5 | information -- strike that.
- 6 What did you understand it to mean?
- 7 A. I understand there is no assurance, and at any time it
- 8 |could be open to the public.
- 9 Q. Because what did he say? Read it again.
- 10 A. Because he said this grand jury proceedings are secret and
- 11 at possibility of eventual disclosure, speculative at this
- 12 | time.
- 13 Q. Did at any point anybody assure you at any proceedings
- 14 that this information would not be disclosed to the Shimbet?
- 15 A. Never.
- 16 Q. What was your understanding as to how this information had
- 17 come in the first place, Mr. Alwan?
- 18 A. It came from the heart of the Shimbet.
- 19 Q. How do you know it did?
- 20 A. It's out of the questions and out of the --
- 21 ||Q. You got to speak up. They got to understand you, man.
- 22 A. Out of the questions I been asked and about the statements

"I was also outraged about the very unclean and unsanitary conditions I personally observed concerning his confinement and detention in that military prison. There was even feces and urine where I met with my son."

"At the time of my first being able to see my son Sharif, he told me in the presence of his mother, my wife, and his two brothers, Yasser Ahmad Alwan and Ramadan Ahmad Alwan, that he had been exposed to severe, inhumane and degrading treatment by the security police authorities who had arrested and/or confined him in a military prison."

"This included the deprivation of food and sleep for extended periods of time and the denial of any medical treatment or care. Sharif reported to me that he was forced to undergo long periods of exhausting -- exhausting interrogation which left him dazed, confused and afraid."

"Sharif specifically told me that he had been confined to a very small and dark cell for a long periods of time.

Sharif also told me he was tied with his arms and hands behind

25 his back to a small chair which had shorter legs in the front

- of it to prevent him from sleeping and which caused great pains
 in his legs."
- 3 "While tied to this small chair, he told me that he
- 4 was hooded with a dirty, foul-smelling sack for extended
- 5 periods of time which did not permit him to see anything,
- 6 | including his interrogators, and made it difficult for him to
- 7 | breathe and added to his fears."
- 8 "Further affiant saith not."
- 9 Who is that signed by, Mr. Alwan?
- 10 A. That's signed by Ahmad Muhammad Alwan, my father.
- 11 Q. Do those paragraphs in this affidavit that counsel asked
- 12 you about demonstrate the fears that your father spoke of
- 13 publicly?
- 14 A. Yes, they are.
- MR. GILLOGLY: Well, Judge, objection about his
- 16 ||interpretation of his father.
- 17 Your Honor, I think a limited instruction on the
- 18 proper use of this affidavit, which is otherwise hearsay, is in
- 19 order.
- 20 THE COURT: I'm going to overrule the objection. I'll
- 21 | consider a limiting instruction at some other point.
- 22 Do you have anything else?
- MR. HILL: Yes.
- 24 BY MR. HILL:
- 25 Q. Mr. Alwan, you told the ladies and gentlemen of this jury

- 1 | that you're testifying even though you don't want to testify
- 2 | now, isn't that correct?
- 3 A. That's correct.
- 4 $\|Q$. Would you tell them what you hope will be accomplished by
- 5 your testifying now?
- 6 A. My hope is to become an American citizen, just like
- 7 everybody of you, who have his rights, and I hope that I will
- 8 bring my family and kids to the United States.
- 9 Q. Are you still concerned for your family?
- 10 A. Sure I do.
- 11 Q. Why?
- 12 A. Because they still live there.
- 13 Q. Has anyone up until this very day, this very hour or
- 14 | minute offered your family any protection?
- 15 MR. GILLOGLY: Objection, your Honor.
- 16 BY THE WITNESS:
- 17 A. No, sir.
- 18 THE COURT: Overruled.

- 10 Q. Sure. June 7th, 2000.
- 11 A. Yes, yes.
- 12 Q. Ms. Jarad was there.
- 13 A. Yes.
- 14 Q. And they made arguments to Judge Aspen about why you
- 15 |shouldn't have to testify.
- 16 A. Yes.
- 17 Q. And you've already told this jury that nobody ever said
- 18 anything to any judge in this building about the stuff that
- 19 | supposedly happened to you in -- by Shimbet, right?
- 20 A. Yes.
- 21 Q. And that includes June 7th.
- 22 | A. It was no specific things that we bring by whatever
- 23 | happens exactly in the Shimbet, but they bring the issue of the
- 24 | fear -- yes, that's right.
- 25 Q. In fact, your lawyer told Judge Aspen and the prosecutor

- that you were afraid of being prosecuted in your homeland, do
 you remember that?
- 3 A. Yes.

- Q. And then Mr. Chanenson made some arguments, and that's when he told you in front of you that the grand jury
- 6 proceedings were secret.
 - MR. HILL: Your Honor, objection. On the theory of completion, I'd like him to read all of what Chanelson said.
- 9 MR. GILLOGLY: Judge, I haven't read anything.
- 10 MR. HILL: His entire sentence.
- 11 THE COURT: Nothing has been read. The objection is 12 overruled.
- 13 BY MR. GILLOGLY:
- 14 |Q. Right, Mr. Alwan?
- 15 A. Would you repeat the question, please?
- 16 Q. Right, and then after Ms. Jarad made her argument about
- 17 | you being afraid of being prosecuted in your homeland,
- 18 Mr. Chanenson responded to Ms. Jarad's argument and in so
- 19 doing, and when he responded, he reminded everyone in the room
- 20 that grand jury proceedings were secret.
- 21 A. Yes.
- 22 Q. All right. And that any possible disclosure, possible
- 23 disclosure, was speculative. Do you remember hearing that?
- 24 A. I did not understand the question.
- 25 Q. Do you remember Mr. Chanenson saying that the grand jury's

- proceedings were secret and possible disclosure was speculative.
- Do you remember that? Mr. Hill just asked you about them.
- 5 MR. GILLOGLY: May I approach, your Honor?
- 6 THE COURT: Yes.
- 7 BY MR. GILLOGLY:
- Q. Do you have Grand Jury Exhibit -- or excuse me -- 9 Government Exhibit 8 up there, Mr. Alwan?
- 10 A. Yes, I do have.

- 11 Q. Would you turn to page 6 then.
 - Okay. Again, I'm retracing ground here, Mr. Alwan, but Mr. Chanenson said, "At this point, Mr. Alwan's fear, I would submit to your Honor, is premature and not necessarily objectively reasonable. These grand jury proceedings are secret, and the possibility of eventual disclosure is speculative at this time."
- 18 Did I read that correctly?
- 19 A. I'm sorry, I'm not catching up which line you are in.
- 20 Q. I'm sorry. Starting at line 16, sir. I'll try it again.
- 21 While you were present and in your presence, Mr. Chanenson
- 22 said: "And at this point, Mr. Alwan's fear, I would submit to
- 23 | your Honor, is premature and not necessarily objectively
- 24 reasonable. These grand jury proceedings are secret, and the
- 25 possibility of eventual disclosure is speculative at this

- 1 ||time."
- Did I read that correctly, sir?
- 3 A. Yes, you did.
- 4 Q. Now, Mr. Hill asked you, well, what did you understand
- 5 | that to mean?
- 6 Do you remember he just asked you that question?
- 7 A. Yes.
- 8 Q. All right. And you said, to the effect anyway, that you
- 9 | weren't sure that they were going to be secret. Is that a
- 10 | correct summary of what you said?
- 11 A. Yes.
- 12 Q. All right. Now, you had a chance to talk to Judge Aspen
- 13 | that same day, didn't you?
- 14 | A. Yes, I did.
- 15 Q. In fact, about five pages later in this transcript, you
- 16 did speak to Judge Aspen directly yourself, didn't you?
- 17 | A. Excuse me, which page?
- 18 Q. Five pages later, page 11.
- 19 ||A. Thank you.
- 20 Yes, I did speak with him.
- 21 |Q. All right. And you personally spoke to Judge Aspen. Not
- 22 | Ms. Jarad, not Mr. Hill, you, Sharif Alwan, and you didn't say
- 23 anything to Judge Aspen about being uncertain now about the
- 24 | secrecy of grand jury proceedings, did you?
- 25 A. No, I did not.

- 1 Q. And neither Mr. Hill nor Ms. Jarad said anything to Judge
- 2 Aspen at that time about there being any concern about the
- 3 secrecy of the grand jury, did they?
- 4 A. No, they did not.
- 5 Q. And, Mr. Alwan --
- 6 | A. Yes.
- 7 Q. -- at the end of the day on June 7th of 2000, having your
- 8 two lawyers make their arguments and their motion to the judge,
- 9 and the Court having heard from the government, your two
- 10 | lawyers and you, the Court entered an order, is that correct?
- 11 A. That's correct.
- 12 |Q. And your effort, sir, to be relieved of the obligation to
- 13 | testify was denied.
- 14 | A. Yes.
- 15 |Q. In short, Mr. Alwan, after a full hearing with a lawyer,
- 16 | you lost.
- 17 A. That's right.
- 18 Q. Now, you told this jury that what you want to do is you
- 19 | want to become an American citizen. Do you remember just
- 20 | telling them that a few minutes ago?
- 21 A. Yes, that's correct.
- 22 |Q. And I think you told the ladies and gentlemen on
- 23 ||cross-examination earlier today that you understand that one of
- 24 the obligations of being a citizen is to obey the law.
- 25 A. Yes.

- 1 Q. And is to obey the lawful orders of the court.
- 2 A. Yes.
- 3 Q. You, Sharif Alwan, chose not to obey the lawful order of
- 4 Judge Kocoras of June -- July 11th, 2000.
- 5 A. Excuse me. I object to that form of that question because
- 6 you said "you chose." I said I have no choice.
- 7 Q. Sir, you made a decision --
- 8 A. Thank you.
- 9 Q. -- not to obey Judge Kocoras's order, didn't you?
- 10 A. Yes.
- 11 Q. And that decision was to not testify.
- 12 A. Yes.
- 13 MR. GILLOGLY: Thank you, Judge.
- 14 FURTHER REDIRECT EXAMINATION
- 15 BY MR. HILL:
- 16 Q. Mr. Alwan, do you believe that becoming an American
- 17 citizen requires that you jeopardize the safety of your wife,
- 18 your family and your father?
- MR. GILLOGLY: Objection.
- THE COURT: Okay. Overruled.
- You can answer.
- 22 BY THE WITNESS:
- 23 A. I believe becoming an American citizen would give me more
- 24 rights, more rights to protect myself here and in my country,
- 25 too, when I go back.
