Revealing this information may jeopardize (G), (P) [REDACTED] life or safety. It may also jeopardize his chances of obtaining employment connected to the Arab community. they need to subpoena him without revealing his prior contact with SA Gamal Abdel-Hafiz.

On 3/12/1999, while SA Abdel-Hafiz was returning to Dallas, Texas, from an in-Service at the FBI Academy, he met a long time friend, (G), (P) who resides at (G), (P) (G), (P) who is an (G) for a company called (G) and currently handles (G) for same, advised SA Abdel-Hafiz that his boss, (D), (G), (P) was subpoenaed to testify before a Federal Grand Jury in Chicago. (G), (P) was concerned for several reasons:

(G), (P) advised SA Abdel-Hafiz of his uneasy feeling with the situation and asked if he should resign. SA Abdel-Hafiz advised (G), (P) that he (Abdel-Hafiz) is not aware of any investigation regarding those individuals nor the companies he mentioned. SA Abdel-Hafiz advised (G), (P) to remain with his employment as long as he desires and there should not be any reason to be alarmed. SA Abdel-Hafiz also advised (G), (P) to continue carrying out his duties as usual.

(G), (P) advised that if he is questioned or subpoenaed by the FBI he will appear and tell the truth regarding their inquiries.
