FEDERAL BUREAU OF INVESTIGATION

Date of transcription 6/30/98

On 6/26/1998, during the American Muslim Council convention, (G), (P) introduced himself to Special Agent (SA) [redacted] of the Federal Bureau of Investigation (FBI) as the same person who called him earlier this month from Florida. SA [redacted] advised (G), (P) that he [redacted] had attempted to call him on Wednesday 6/24/1998, but he did not find him at his office and was told that he (G), (P) is expected back in his office on Monday 6/29/1998. [redacted] advised SA [redacted] that he did not receive this message. SA [redacted] advised (G), (P) that he (G), (P) could call him when he returns to his office next week.

(G), (P) asked if SA [redacted] was able to find anyone at the FBI who could talk to Mr. (P) SA [redacted] advised (G), (P) that he was not able to find anyone who will confirm or deny Mr. (P) claim because this is the FBI's policy. (G), (P) thanked SA [redacted] for trying to assist in this matter.

On 6/26/1998, during a dinner which was attended by SA [redacted] and (G), (P) asked SA [redacted] why would an FBI Agent attempt to meet with him (G), (P) alone without his attorney. (G), (P) went on stating that SA (P) of the Tampa-Clearwater FBI office approached an acquaintance of (G), (P) and requested that the acquaintance arrange a meeting between SA (G), (P) without his (G), (P) attorney being present.

(G), (P) also advised that a person from the Tampa FBI office advised him that his case agent (SA (P) [redacted]) have always worked interstate theft violations and he does not understand anything about (G), (P) case. (G), (P) also advised that the same person from the Tampa FBI office told him that SA (P) [redacted] should have retired two years ago but was granted extensions because of (G), (P) case and SA (P) [redacted] maybe exaggerating the facts about this case to remain with the FBI as long as he can.

(G), (P) also asked SA [redacted] if the FBI would fabricate evidences against anyone. SA [redacted] advised (G), (P-1) (G), (P) that he (SA [redacted]) had never heard of the FBI

(G), (P) also advised that the FBI approached one of his former students who worked at a computer company and asked him to cooperate with them against (G), (P) in exchange for a permanent residence card (i.e. the green card) and a job with IBM. When the person refused the offer he was arrested a week later and processed for deportation.
