Conduct no investigation until so requested by OPR. Initiation and conduct of this inquiry and adjudication as necessary should be closely coordinated with OPR.

On 5/16/01 an OPR inquiry was initiated regarding an allegation that unknown subject(s) were involved in the unauthorized disclosure of classified information to the United States Attorney's Office, Northern District of Illinois. On 10/11/01, this OPR inquiry was expanded to include an allegation that captioned employee engaged in investigative dereliction resulting in a violation of the Intelligence Oversight Board (IOB-2001-37) requirements and was involved in the unauthorized disclosure of classified information.

— You are requested not to inform captioned employee of the initiation of this inquiry or provide him/her with the below described forms until requested to do so by OPR.

— You are requested to provide captioned employee with a copy of this notice and of the attached forms, "Explanation of Procedures in the FBI's Disciplinary Process" and "Disclosure of Information to Attorneys," and to return this notice signed and dated by the presenting official, establishing that you have advised the employee that:

- (1) He/she will be interviewed regarding this matter,
- (2) He/she has the opportunity to have an attorney represent him/her in this matter subject to the limitations set forth in the above forms, and
- (3) The Employee Assistance Program (EAP) is always available and provides free, confidential, professional assistance to employees and their family members. Employee should be provided an EAP informational brochure with the name(s) and contact number(s) of their division EAP Representative(s) listed.
- (4) He/she has the opportunity, prior to being interviewed, to voluntarily provide documentation, information, or explanation, that may assist in the resolution of this inquiry.
- (5) He/she should not discuss this matter with anyone other than the FBI personnel assigned to conduct the inquiry, OPR representatives, EAP representatives, the FBI's Ombudsman, and/or his/her attorney, without the prior concurrence of OPR.
