Sir,

The Bureau's prepublication review policy for current employees requires I submit my manuscript to OPCA for prepublication review.

My attorneys, Larry Klayman, Judicial Watch, 501 School Street, S.W., Suite 725, Washington, D.C. 20024 and David Schippers, Shippers and Bailey, 20 North Clark St., Chicago, IL 60602 are currently scheduling early November meetings with U.S. Congressmen and U.S. Senators to discuss the contents of my manuscript. Although I am not submitting the Request to Engage in Outside Employment Form (FD-331) at this time, I intend to contact several publishers in the future to discuss the publication of my manuscript for monetary compensation. I will submit the FD-331 prior to contacting any publisher regarding negotiation for compensation.

The manuscript was not prepared on Bureau time and was not part of a previously approved FBI project. Documents utilized were obtained through domestic and international news agencies, court records and FOIPA. The manuscript contains 712 endnotes which identify the source documents. The source documents utilized in connection with the preparation of the manuscript are being furnished in two separate binders containing approximately 750 pages.

I intend to identify myself as a Special Agent within the rules established by the Bureau. I am not presently assigned nor have I been assigned to terrorism matters during the past two years. The manuscript is non-fiction and the names mentioned in the manuscript will be changed prior to actual publication.

I have not made any oral or written disclosures of drafts, initial manuscripts and so forth to any publishers, co-authors, ghost writers and/or unauthorized individuals. I have not contacted any publishers regarding my manuscript.
