Title: DOCUMENT EXPLOITATION
TDY MATTERS

Synopsis: To advise Chicago Division of the exceptional work performed by SA Robert G. Wright, Jr. during a 133 day Temporary Duty (TDY) assignment at the Counterterrorism Division, Communications Exploitation Section (CXS), Document Exploitation Unit (DocEx).

Details: SA Wright served a 133 day TDY from August 10, 2003 to December 17, 2003. During SA Wright's assignment in DocEx, he successfully completed numerous, time sensitive, high profile assignments.

On a daily basis, SA Wright interacted with multi-agency personnel dealing with the coordination, reviewing and dissemination of time sensitive intelligence extracted from CT subjects. SA Wright acted as the point of contact between the Defense Intelligence Agency (DIA) translators and FBIHQ DocEx personnel to provide actionable intelligence to the Field and FBIHQ substantive units. SA Wright represented the Bureau well during his interaction with DIA linguists.

SA Wright was also responsible for the reconciliation of thousands of evidentiary materials obtained through international searches and seizures. After the evidentiary materials were received by DocEx, SA Wright would review, prepare and enter evidentiary items into an Access database. The evidentiary materials were then imaged and uploaded into the IntelPlus database. The IntelPlus is an invaluable source of information that enables DocEx to provide assistance and case support to the Field Offices.

SA Wright also assisted in substantially reducing the number of outstanding leads assigned to DocEx. He conducted numerous IntelPlus record checks and performed raw
